Regulations on Conducting Follow-up Evaluation and Re-evaluation for Institutional Evaluation of Technological Institutions

Approved by the 1st meeting of the 1st Evaluation Committee for Institutional Evaluation of Technological Institutions on May 29, 2010

- Art. 1 The Taiwan Assessment and Evaluation Association (hereinafter referred to as the Association), for the purpose of handling the follow-up evaluation and re-evaluation of the evaluation of technological institutions, establishes the Regulations on Conducting Follow-up Evaluation and Re-evaluation for Institutional Evaluation of Technological Institutions in accordance with Article 11 of the Regulations of the Evaluation Committee for Institutional Evaluation of Technological Institutions (hereinafter referred to as the Committee; hereinafter referred to as the Regulations).
- Art. 2 The results of the evaluation of school affairs of technological institutions shall be "passed", "passed with conditions", or "failed" for each assessment item.
- Art. 3 Institutions with "conditional pass" in the school affairs assessment shall be subject to the follow-up evaluation. Within one year from the publication of the assessment results, the institution shall submit a "self-improvement plan and implementation results" and be subject to follow-up evaluation in the same year to review the improvement results of the items to be improved in the "conditional pass" assessment.
- Art. 4 institution with "failed" institution evaluation results shall be re-assessed. Within one year from the publication of the evaluation results, the institution shall submit a "self-improvement plan and implementation results" and be re-evaluated in the current year, and re-assessed for the "failed" assessment items.
- Art. 5 Each institution shall be evaluated on a one-day basis, and the number of assessment committee members for each assessment item shall be two to three.
- Art. 6 For re-evaluation, each evaluated institution shall have one day, and the number of evaluation members for each evaluation item shall be four to five.
- Art. 7 The operation contents such as the documents to be submitted by the evaluated





institutions for follow-up evaluation and re-evaluation, the on-site evaluation process, and the processing of the evaluation results shall be specified by the Association in the implementation plan and communicated to the evaluated institutions.

- Art. 8 The results of the follow-up evaluation and re-evaluation shall be reviewed in accordance with the original institution evaluation, and the assessment report shall be completed after the resolution of the Accreditation Review Committee, and the "evaluation results" shall be submitted to the Board Meeting, and presented to the Ministry of Education for record, and announced and written to the evaluated institution.
- Art. 9 If the results of the follow-up evaluation and re- evaluation are "passed," "passed with conditions," or "failed," the validity period shall be from the date of announcement of the evaluation results to the remaining time of the original evaluation.
- Art. 10 These Regulations shall be effective upon the approval of the Committee and shall be subject to amendments.
